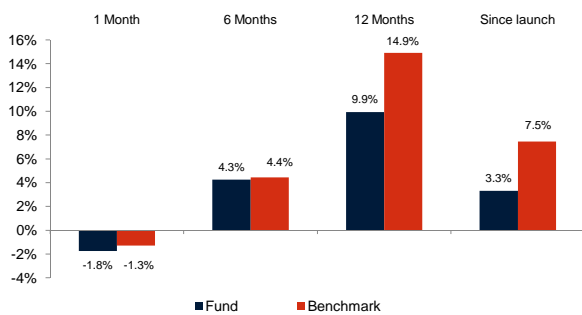

### Investment objective

A diversified portfolio consisting of assets in liquid form and participatory interests of portfolios of collective investment schemes or other similar schemes, which invests across all market sectors into a wide range of asset classes that includes cash, equity, fixed income, high yield and property investments. The portfolio aims to provide a balance between capital preservation and capital growth over the full investment cycle. The Cell is ideally suited to investors with an investment horizon of 3 years or longer.

### Market commentary

The run in global markets reversed in May as the MSCI AC World Index declined 2.2% with Emerging markets leading declines by 2.6% and Developed markets down 2.1%. The Citigroup World Government Bond Index lost 0.1%.

Despite another welcome increase in non-farm payrolls, US unemployment rose to 9.0% (against expectations for the indicator to remain stable). CPI also surprised on the upside, increasing by 3.2%, continuing to place pressure on the Fed to reverse monetary easing.

A similar situation continues in the UK and EU, where CPI remains persistently above government targets. Given the risk of a further bailout package requirement by Greece, or even possible default, the ECB's monetary policy stance will be closely monitored.

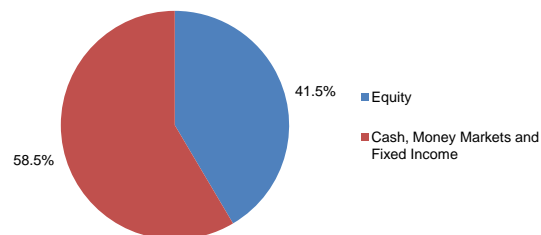
Chinese CPI declined to 5.3%, but remains above the PBOC target of 4.0% set for the year. Consequently, the PBOC hiked the reserve requirement a further 50bps to a record high of 21.0%.

The US dollar has strengthened on the back of renewed global risk aversion and the euro and emerging market currencies have reversed recent gains accordingly.

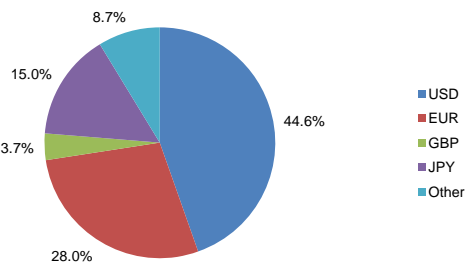
We have further increased our global inflation-linked bond position and continue to watch this space. We maintain an overweight position in equities whilst retaining government bonds to a minimum.
