

Investment objective

The portfolio aims to provide a balance between capital preservation and capital growth over the full investment cycle. Market commentary

Global equity markets dipped in October as investors continued to worry about fiscal constraints to global growth despite the adoption of pro-growth monetary policies by most major central banks. The MSCI All-Country World Index posted a negative return of 1.19% in US dollar terms. Developed and emerging markets returned -1.23% and -0.87% respectively. Global bonds declined 0.64%.


Economic data remains mixed, depicting a soft global economy that has seen growth slow to a pace of 3.3% in 2012 so far, amidst on-going difficulties in Europe. The IMF went on to forecast modest growth in the US of 2.2% and overall growth in the emerging nations at a pace of 5.3%. The upward revision of US growth has featured prominently in many company earnings reports in recent weeks. In the euro area, the PMI Manufacturing Survey hit a new cycle low of 45.3 in October. In contrast, China's increase in Manufacturing PMI to 50.2 and unexpected surge in industrial production to 9.2% suggests that China's growth slowdown is abating.

Further flare-ups in Europe's sovereign debt crisis were exacerbated when S&P slashed Spain's debt rating to BBB-, mounting pressure on Madrid's finances. Moody's then downgraded five Spanish regions, citing poor liquidity and maturing bond repayments. The downgrade in credit ratings comes on the heels of regional elections. Madrid is still trying to delay its application for an aid programme.


Markets remain in uncertain territory and thus we maintain a cautious approach. Equity remains the best valued asset class at this time, and we remain marginally overweight. Fixed interest is materially overvalued and we maintain an underweight position here. We believe that assuming a more active investment approach, particularly in the area of stock selection, will assist in adding value in these uncertain times.
