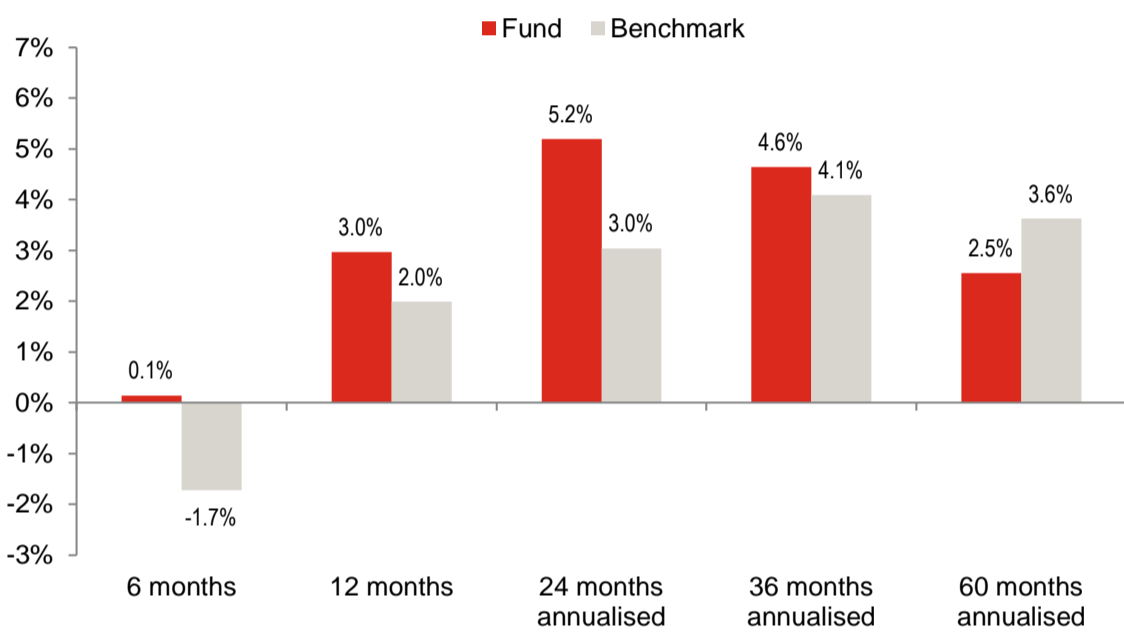

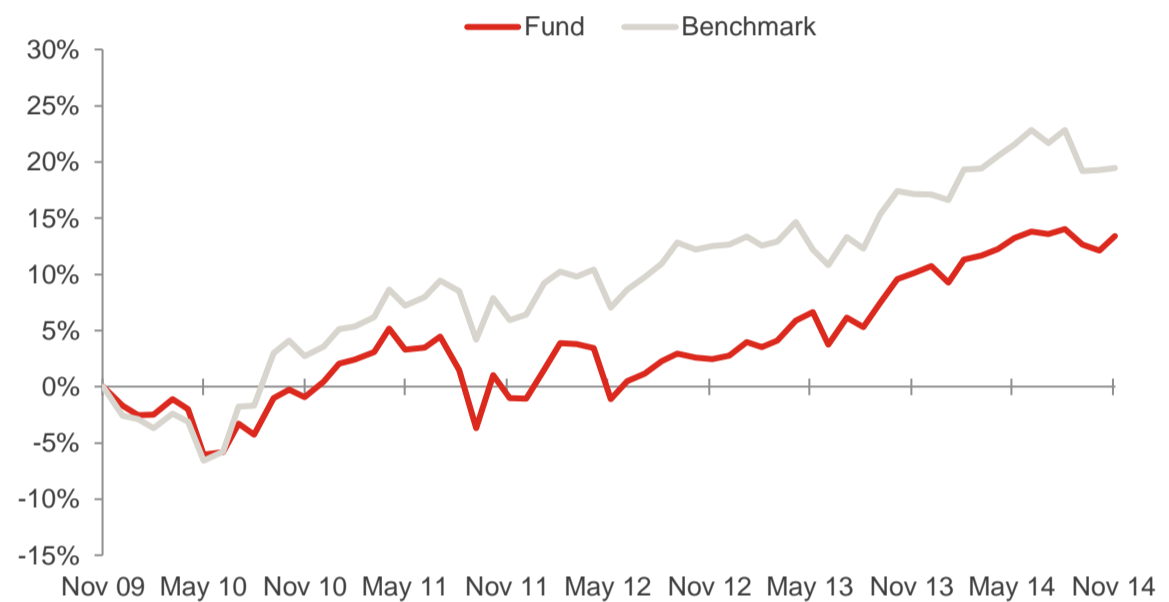
Investment objective

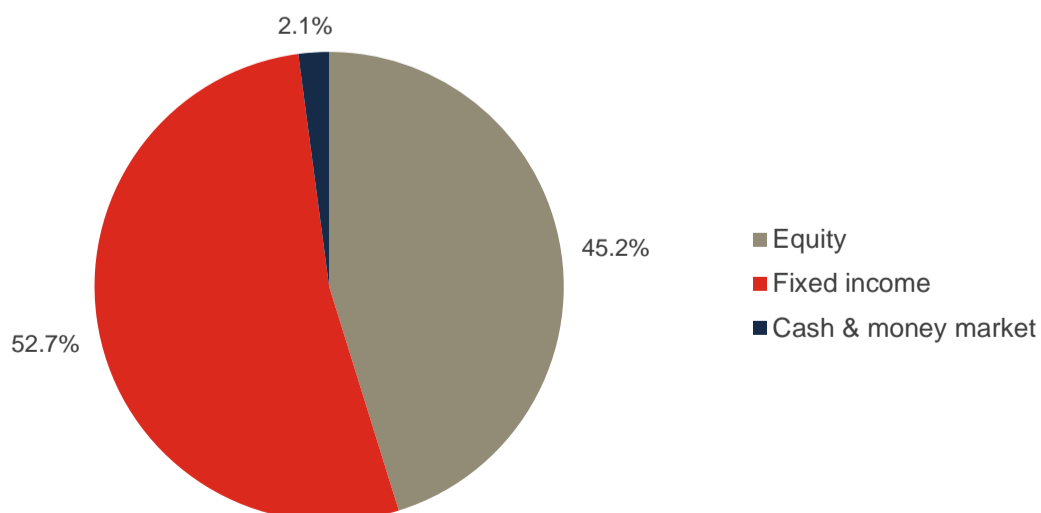

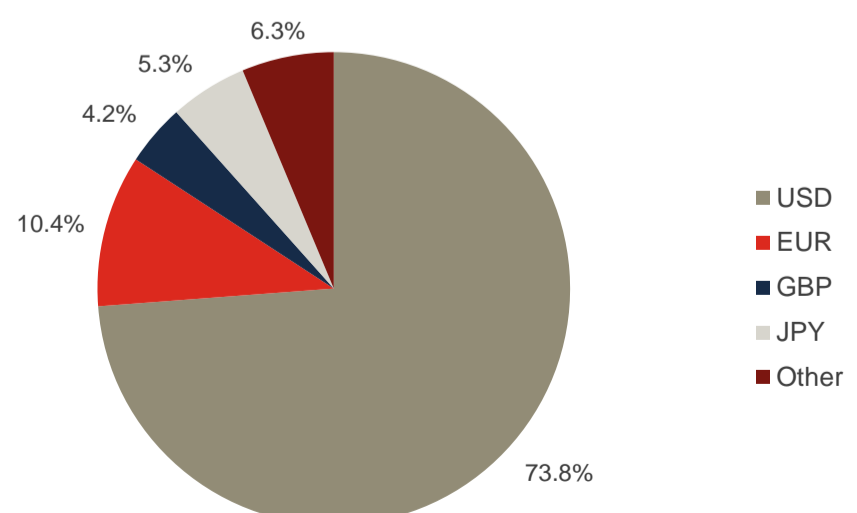

■ Market commentary

Overall global developed equity markets saw positive gains this month. In US dollar terms, the MSCI AC World Index rose 1.7% with developed markets gaining 2% while emerging markets lost -1.1%. The German Dax 30 Index led gains with 6.5% in November, followed by the Nasdaq at 4.4%, the Dow Jones Euro Stoxx 50 at 4%, the French Cac 40 at 3.2%, the S&P 500 at 2.7% and the Nikkei 225 at 0.5%. Global bonds lost a further 0.5% in US dollar terms.

US equities rose to new record highs during the month on the back of positive economic data. US GDP expanded to 3.9% for the third quarter, greater than the previous estimate of 3.5%. US unemployment declined to 5.8% as the labour force participation rate rose to 62.8%, although changes in private and non-farm payrolls disappointed more than expected.

In Japan preliminary third quarter GDP improved from the -7.1% decline in the second quarter, although remaining in negative territory at -1.6% and well below expectations of an improvement to 2%. At the end of October the Bank of Japan injected additional stimulus into their economy by stepping up purchases of government bonds and Japanese stock funds.

Central banks seem to be driving markets with China following the path of the Fed, the European Central Bank (ECB) and the Bank of Japan (BoJ).

China surprised markets with an unexpected interest rate cut in November in an effort to support their economy as it heads towards its slowest expansion in nearly a quarter of a century. The People's Bank of China cut one-year benchmark lending rates by 40 basis points to 5.60% and lowered one-year benchmark deposit rates by 25 basis points. The first cut in over two years sparked a bounce in almost all markets around the world this month.

We remain cautiously optimistic as we head towards the end of this year and continue to monitor markets closely.
