

Investment objective

The cell focuses primarily on long-term capital growth over the full investment cycle through a relatively high exposure to international growth assets. The portfolio will retain a good level of diversification, however, and will invest in a wide range of asset classes including cash, bonds, equities and property. The Cell is suited to investors with an investment horizon of 5 years or longer and an intermediate (between moderate and high) risk tolerance.

Market commentary

Global markets ticked up this month gaining 1.40% in US dollar terms amid stimulus, led by Emerging Markets at 1.95% while Developed Markets rose 1.29%. Global bonds returned 1.13%.

Global markets reacted positively when Europe's major central banks delivered a further round of monetary stimulus. The European Central Bank cut its key lending rate by 0.25% to 0.75%, taking it below 1% for the first time in the bank's history; and reduced the interest rate on overnight deposit facilities to 0% as a measure to push banks to lend more. The Bank of England increased its asset purchase programme by £50 billion to £375 billion, and the Bank of China cut its one-year lending rate by a further 0.31% to 6.0%.


However, volatility remains and market tension mounted as the IMF/ECB/European Commission debated whether to keep Greece hooked onto its €130bn lifeline, and how to recapitalise Spain's failing banks and finance its debt. Spain's 10 year government bond yield spiked to a new high of 7.59%. The flight to safety was reflected in record low yields in Germany and the US at 1.16% and 1.40% respectively.

UK GDP collapsed to -0.80% from -0.20% in the second quarter of 2012, caused by weakness in the manufacturing and construction sectors. US GDP also slowed to 1.50% from 1.90% over the same period, but the US Earnings Season which kicked in this month has not shown any red flags so far. China GDP slumped to 7.60%.


We maintain a cautious approach in an environment of rising uncertainty and believe that adopting a more active approach will add value to our portfolios, especially in equities. We remain underweight Government fixed interest and overweight offshore cash.
