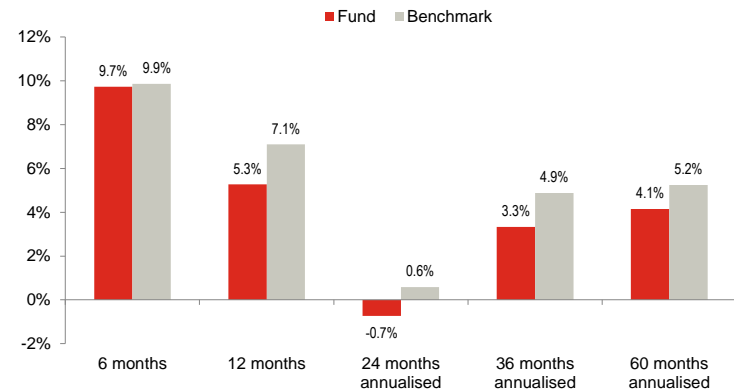

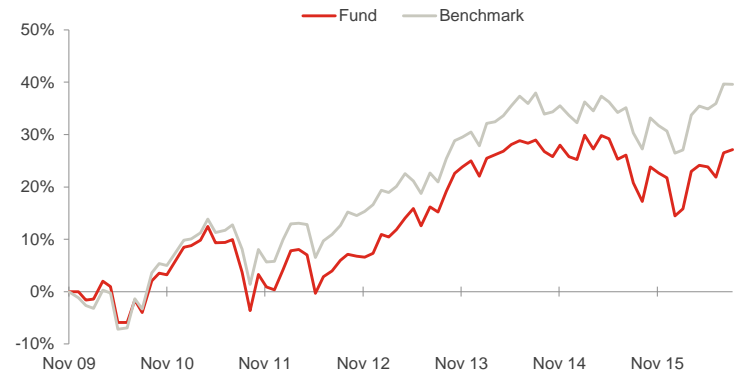
## Investment objective

The Fund focuses primarily on long-term capital growth over the full investment cycle through a relatively high exposure to international growth assets. The portfolio will retain a good level of diversification, however, and will invest in a wide range of asset classes including cash, bonds, equities and property. The Fund is ideally suited to investors with an investment horizon of 5 years or longer and an intermediate (between moderate and high) risk tolerance.

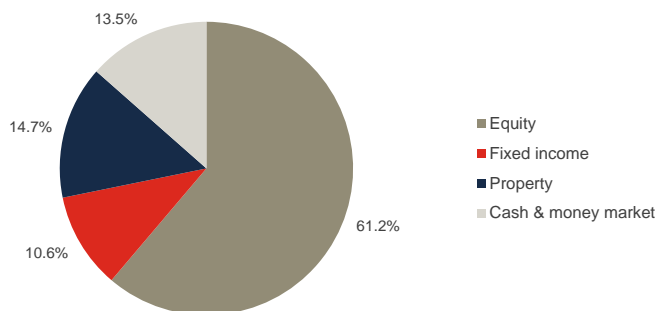

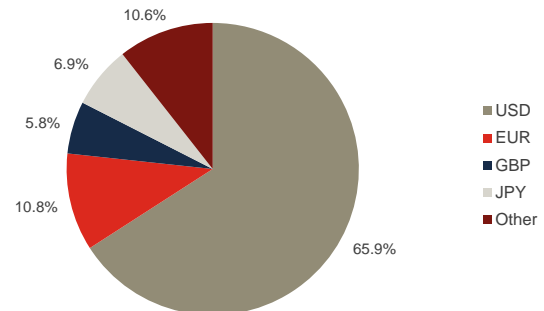

## ■ Market commentary

---

Global markets were positive throughout August with the MSCI AC World index gaining 0.34%. Emerging markets continued to outperform developed markets, gaining 2.49% and 0.08% respectively in US dollar terms. Global bonds lost -0.84% in US dollar terms.

The British economy held up relatively well post-Brexit. Exports in the manufacturing sector have increased on the back of the rapid depreciation in the value of the pound relative to the US dollar. Prime Minister May indicated that negotiations around leaving the EU were only likely to start in 2017 and the whole process is expected to take several years to conclude.

US economic data remained generally positive. Over the second quarter, the economy was supported by strong growth in consumer spending. The unemployment rate remained steady at 4.90%. Federal Reserve ("Fed") chair, Janet Yellen, noted that the labour market had continued to perform solidly. Most economists now believe that the Fed will raise interest rates in December after the presidential elections on 8 November.

Market participants remain cautious based on the uncertainty regarding the possible impact of the US Federal Reserve raising rates in a global environment where most other central banks are being forced to continue to stimulate their own lagging economies. We believe this could result in continued volatility in growth and other risk assets which call for a measured approach, yet we remain confident that this will also bring opportunities as we remain focused on the longer term fundamentals.
