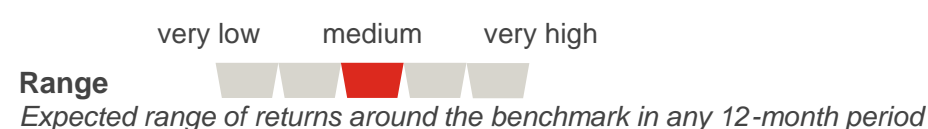
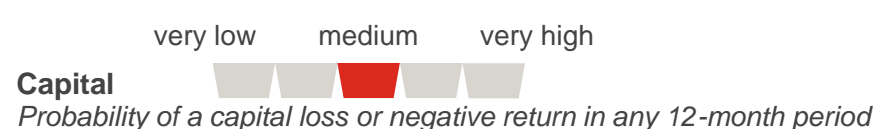

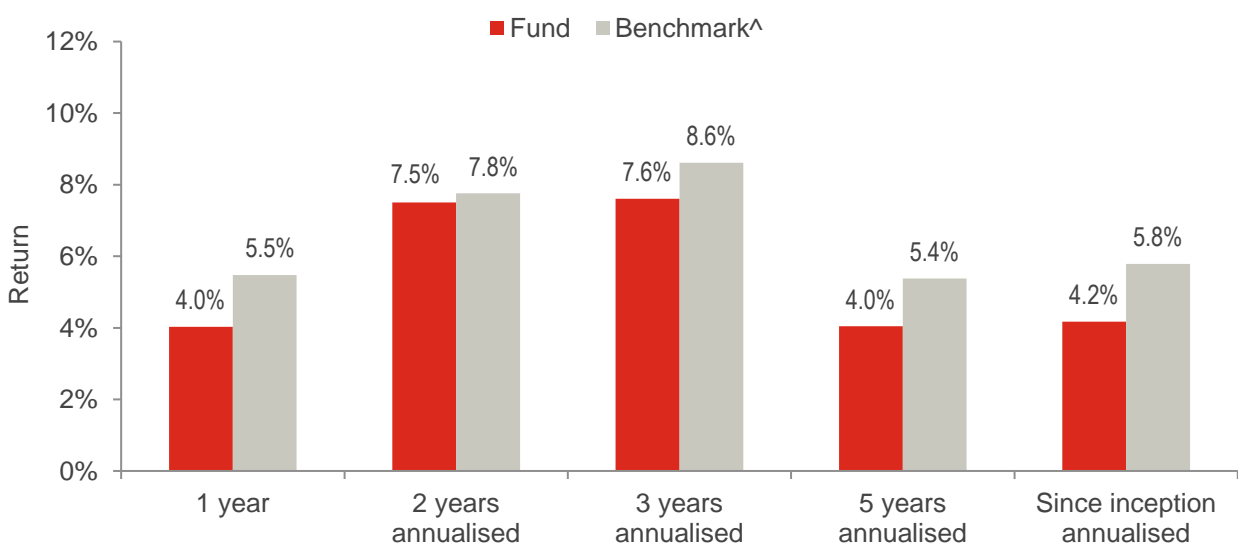

## Investment objective

The Fund focuses primarily on long-term capital growth over the full investment cycle through a relatively high exposure to international growth assets. The portfolio will retain a good level of diversification, however, and will invest into a wide range of asset classes including cash, bonds, equities, commodities and property. The Fund is ideally suited to investors with an investment horizon of 5 years and longer and an intermediate (between moderate and high) risk tolerance.

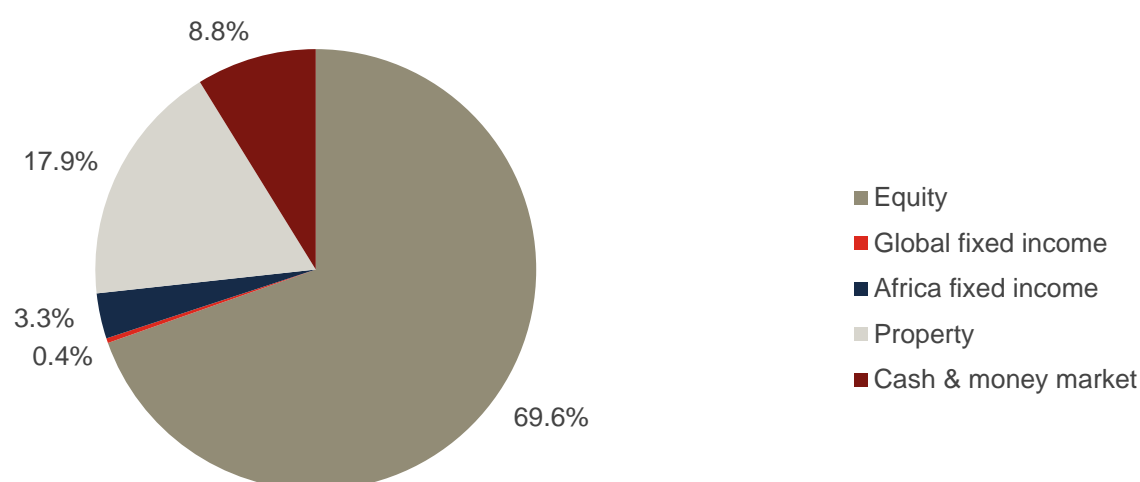

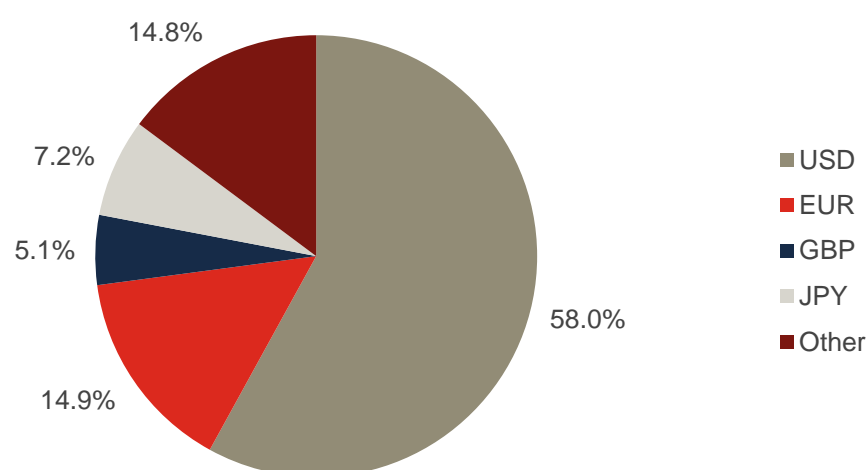

## Market commentary

After the sharp falls in emerging market currencies and markets in the previous month, a degree of stability returned in September. The US equity market advanced 0.5%, with indexes reaching new all-time highs. The MSCI World Index was up 0.6% in dollar terms with all regions producing gains, with the exception of Asia ex Japan as the trade war between the US and China intensified. US President Trump imposed additional tariffs on \$200bn of Chinese imports and, in response, China retaliated imposing tariffs on a further \$60bn of US imports. Emerging market equities were down modestly, falling 0.5% in dollar terms, although EM currencies and emerging market bonds both rallied.

The Federal Reserve raised its target for the federal funds rate by 25bps to between 2.0-2.25%, a move which was widely anticipated by the markets amid strong US growth and record-low unemployment. The Fed steered the market to expect a further rate rise in December and at least another three next year.

In Europe, the Italian government produced its 2019 budget, targeting a fiscal deficit of 2.4% of GDP, thereby exceeding the 2% limit set by the European Commission. After performing well during the month up to the announcement, Italian bonds and equities, especially bank shares, fell sharply. The European Union rejected UK Prime Minister May's Chequers plan for the UK's withdrawal and outline of its future relationship with the EU. Although the UK equity market gained 1.4% over the month, the fear of a no-deal Brexit grew and undermined UK markets towards the end of the month.

Although the global economy generally is in good shape, with reasonable growth combined with low inflation, this is not a time for investor complacency. Greater resilience is warranted in portfolios and the inevitable setbacks will present opportunities to add to positions selectively. While some of the negative developments in recent weeks could be of a relatively short term nature, the trade war between the US and China will persist for some time and could have a rising impact on confidence and growth. Most importantly of all, the Fed will continue to tighten policy by increasing rates, probably to over 3% by the end of 2019, and removing liquidity. It remains an environment to keep duration short and progressively move away from credit into US Treasuries. It will be important to watch for signs of any pickup in inflation in the US, notably in wages, as this would be a potential trigger for an unexpectedly sharp tightening of monetary policy.
