Investment strategy

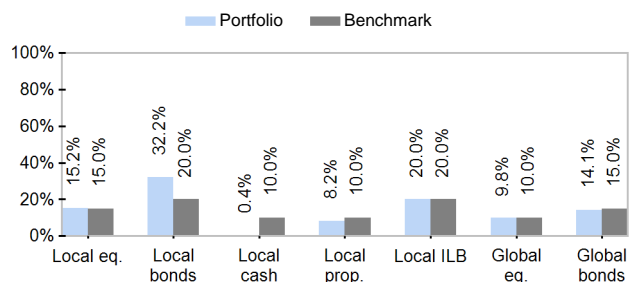
