Investment strategy

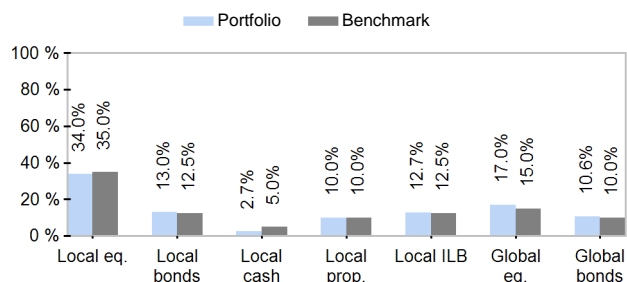
