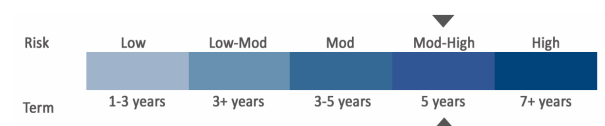

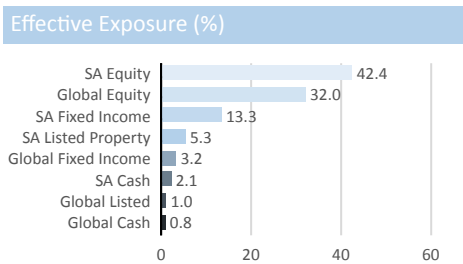
### Moderate - High Risk
