INVESTMENT OBJECTIVE

The Ampersand BCI Global Balanced Feeder Fund aims to provide investors with long term capital growth.

INVESTMENT POLICY

The portfolio will apart from assets in liquid form, invest solely in the participatory interests of the VPFP International Growth Fund IC Limited, an incorporated cell of the Momentum Mutual Fund ICC Limited, domiciled in Guernsey. The underlying portfolio focuses primarily on long-term capital growth over the full investment cycle through a relatively high exposure to international growth assets. The portfolio will retain a good level of diversification, however, and invests into a wide range of asset classes including cash, bonds, equities, commodities and property. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.




RISK PROFILE

Moderate - High Risk
