**INVESTMENT OBJECTIVE**

The Ampersand BCI Cautious Fund of Funds aims to deliver a stable level of income combined with long term capital stability.

**INVESTMENT POLICY**

The portfolio's net equity exposure may be as high as 40% of the portfolio's net asset value to provide a limited level of capital protection. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes, which is consistent with the portfolio's primary objective, investing in, amongst others, equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest-bearing instruments and securities. For the purpose of this portfolio, the manager shall reserve the right to close the portfolio to new investors in order to manage the portfolio in accordance with its mandate.




**RISK PROFILE**
