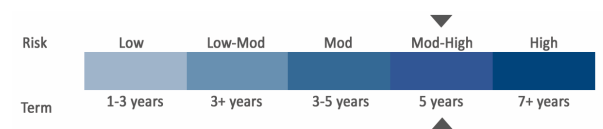

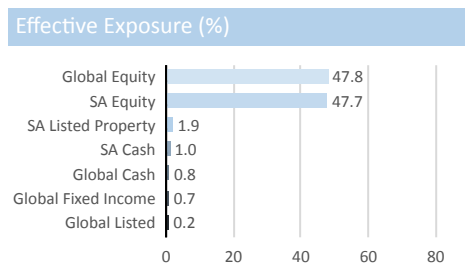
**Moderate - High Risk**
